AILA Declares a Climate and Biodiversity Loss Emergency

Why is AILA declaring a Climate Emergency

In October 2018, an Intergovernmental Panel on Climate Change (IPCC), the United Nations body for assessing the science related to climate change, reported that humanity has just 12 years to restrict global warming to 1.5 degrees Celsius¹ above pre-industrial levels.

Climate change is already evident in Australia, where with a rise of 1.0°C we are disproportionally affected by longer, more intense droughts and extreme weather events. It is in our interest to reduce carbon emissions in all areas of our society and economy as quickly as possible to ensure the viability of the planet for future generations.

Why is AILA declaring a Biodiversity Loss Emergency?

Earth's ecosystems are in decline globally at rates unprecedented in human history – similarly, the rate of species extinctions is accelerating, with grave impacts for people around the world anticipated².

One million of the world's species are now under threat of extinction, according to the biggest-ever review of the state of nature on Earth and half of Australia's nationally threatened animal species occur in areas planned for urban development³, particularly greenfield development, which represents a current threat to Australia's biodiversity.

AILA's Action Plan

AILA has been active in providing leadership through design, strategy and the development of resources – but we acknowledge more can be done.

AILA commits to:

- 1. Continuing to play a crucial role in leading the profession to respond to this unfolding Emergency.
- 2. Continuing to lobby all levels of government to recognise the Emergency, allocate sufficient resources and advise on appropriate policy.
- 3. Promoting landscape architecture as a leading profession in policy development and actions to respond to the Emergency.
- 4. Lead collaboration with allied professions, the community and supporting organisations that have made climate change emergency declarations.
- 5. Engaging with our international colleagues to support the efforts of IFLA to advocate globally.
- 6. Lobbying for improved industry standards and practice.
- 7. Providing resources, education and information to members on how they can respond to the Emergency.
- 8. Calling on AILA's Corporate Partners to develop actions that respond to the Emergency.

AILA members and Registered Landscape Architects are equipped with the knowledge and skills to advise how Living Infrastructure can support governments at all levels with local communities to enhance our towns and cities to make them green, more liveable and healthier.

The role of landscape architects: responding together

AILA acknowledges that this issue requires a broad, coordinated and collective approach to action. While there is a specific role for landscape architects to play, there is also a great need for collaboration with government, the broader built environment and the community.

AILA members will be encouraged to work within their own organisation and practice to make similar declaration. The Action Plan AILA has developed can be adapted and contextualised to different types of practice (sole practitioner, academic, client side, government or private practice).
