

Members representing AILA in external positions or forums

1. Introduction

This policy describes the principles and operation of the appointment, role and reporting of members delegated to sit on external groups, forums, and boards etc as AILA representatives.

2. Objectives

This policy aims to document and consolidate the appointment process and authorities that National Council has provided to members appointed to represent the organisation in line with the following:

- Achieve the Institute's mission through delivery of the outcomes, objectives and initiatives.
- Deliver on the ACAP
- Ensure that committees, officers, staff and appointed members act in accordance with the constitution, regulations and policies of the Institute;
- Ensure delegations of authority are formally documented and transparent to Institute members and other stakeholders;

3. General principles for members representing AILA for national forums/positions

Appointment

- National Council is only able to appoint a member to a position of representation for the organisation.
- Process for appointment includes
 - A National call-out to the membership will take place for nominations for any positions available (unless timing does not permit).
 - National Council will review applications and may seek advice from a National Committee or State Executive before confirming the appointment.
 - The successful representative will be notified and will be required to sign an MOU agreeing to operate within the terms of the role.
 - All appointments will be reviewed annually by National Council soon after each AGM, and reconfirmed or replaced for the following term.
 - A member is only able to occupy an external role representing AILA for a maximum of
 5 years, at which time a call for nominations will be issued to the membership.
 - A member can be removed from the position should they not adhere to the terms of the role or operate in a way that does not act in the best interests of the membership.

Role

- The role may vary depending on the organisation, position and objectives and the detailed role
 will be specified in the call for members and MOU, however the general principles of the role
 will include:
 - Represent the organisation in the best interest of the membership and AILA Strategic objectives.
 - Contribute with the delegated authority to speak as a Landscape Architect representing the organisation.
 - Uphold the values of the organisation in engagement and representation.

- Never operate in the position for personal gain.
- o To provide input to the discussion and debate on the topic area, and seek input and advice from the membership (through surveys, email call outs, focus groups etc).
- o To attend a minimum of 80% of schedule meetings of the group.
- To seek advice from National Council, the CEO or relevant National Committee if additional information is required.
- To seek approval from National Council before committing to any expenditure associated with the role including airfares, accommodation or incidentals associated with the role.
- To ensure that National Council are informed of any areas of content or process that may have a negative impact on the membership or organisation.
- To report twice a year to the National Council, and brief Council face to face should the opportunity arise

4. General principles for members representing AILA for State/Regional forums/positions

Appointment

- State/Territory Executive is only able to appoint a member to a position of representation for the organisation.
- Process for appointment includes
 - A State/Territory call-out to the membership will take place for nominations for any positions available (unless timing does not permit).
 - State Executive will review applications and may seek advice from a State or National Committee or a National Councillor before confirming the appointment.
 - The successful representative will be notified and will be required to sign an MOU agreeing to operate within the terms of the role (created by the State Executive)
 - All appointments will be reviewed annually at the by State Executive soon after each
 State Annual Meeting, and reconfirmed or replaced for the following term.
 - A member is only able to occupy an external role representing AILA for a maximum of
 5 years, at which time a call for nominations will be issued to the membership.
 - A member can be removed from the position should they not adhere to the terms of the role or operate in a way that does not act in the best interests of the membership.

Role

- The role may vary depending on the organisation, position and objectives and the detailed role
 will be specified in the call for members and MOU, however the general principles of the role
 will include:
 - Represent the organisation in the best interest of the membership and AILA Strategic objectives.
 - Contribute with the delegated authority to speak as a Landscape Architect representing the organisation.
 - o Uphold the values of the organisation in engagement and representation.
 - Never operate in the position for personal gain.
 - o To provide input to the discussion and debate on the topic area, and seek input and advice from the membership (through surveys, email call outs, focus groups etc).
 - To attend a minimum of 80% of schedule meetings of the group.
 - To seek advice from State Executive, the State President, the State Chapter Manager or relevant State or National Committee, if additional information is required.

- To seek approval from the State Executive before committing to any expenditure associated with the role including airfares, accommodation or incidentals associated with the role.
- To ensure that the State Executive are informed of any areas of content or process that may have a negative impact on the membership or organisation.
- To report twice a year to the State Executive, and brief State Executive face to face should the opportunity arise
